- The Last date of submission of quotation on 13 - 10-2023 at 14:00 hrs.
- The bidder must have valid GST registration certificate.
- The bidder must provide photo copy of Pan Card.
- **The Quoted price should be inclusive of all taxes applicable to the services.**
- Bid Security 2% for General and 1% for reserved category of quoted value must be submit in the form of Bank Guarantee / FD from Nationalized bank in favour of Secretary Srimanta Sankaradeva Kalakshetra Society, Panjabari, Guwahati-37”
- The expenditure is debit able to the Head of Account –Corpus Fund Interest Account for the year 2023-24.
